### Full Resident Membership:

The Full Resident Membership is open to families and individuals whose permanent address is within Carteret County & Havelock and include both spouses & children 21 years of age and younger. Full Resident Members may play golf any time Monday-Sunday and may make tee times 7 days in advance. Unlimited use of the Driving Range and Chipping & Putting Green. Full Members also have unlimited pool and clubhouse privileges, including club social events. Member voting stock certificate is required.

### Full Non-Resident Membership:

Same privileges as the Full Resident Membership and whose permanent residence is outside of Carteret County & Havelock. Member voting stock certificate is required.

### Junior Membership:

The Junior Membership is available for individuals or families under the age of 40. Junior Members have all the privileges of the Full Resident member. Member voting stock certificate is required.

### Social/Afternoon Golf Resident Membership:

The Social Resident Membership is open to families and individuals whose permanent address is within Carteret County & Havelock. Social members will unlimited pool and clubhouse privileges, including club social events. Social members will also have limited golf privileges. Privileges include unlimited use of the driving range and the ability play golf Monday-Sunday after 12:30pm at Full Member rates. Social Members are able to make tee times 7 days in advance. Social members will not have voting rights.

### Social/Afternoon Golf Non-Resident Membership:

The Social Non-Resident Membership is open to families and individuals whose permanent address is outside of Carteret County & Havelock. Social members will not have voting rights.

### Social/Afternoon Golf Junior Membership:

The Social Junior Membership is available for individuals or families under the age of 40. Social Junior Members have all the privileges of the Social Resident Member's. Social members will not have voting rights.
